About Personal Data Protection

In accordance with the legal provisions entered into force on May 25, 2018 (General Regulation on Data Protection No. 679/2016 - "Regulation of SC MAG TRANZACT SRL, Brasov, 5 Minerva Street, Brasov, Romania having the unique registration code RO27462532, and serial number in the trade register J08 / 1096/2010, represented by Mag Ion Gheorghe, a series of measures were defined and implemented with the aim of ensuring compliance with the provisions of the Regulation.

Ensuring the protection and proper use of personal data is a permanent priority for us. We constantly improve the security and confidentiality of data at the technical and organizational level, to ensure the highest standards. At present, our efforts are aimed at ensuring compliance with the provisions of the Regulation, which strengthens the rights of data subjects and the security of personal data processing in the European Union.

In accordance with the Regulation, personal data represent any information relating to an identified or identifiable natural person; an identifiable natural person is a person who can be identified, directly or indirectly, in particular by reference to an identifier, such as: a name, an identification number, location data, an online identifier or one / more specific factors - physical, physiological, genetic, mental, economic, cultural or social of that natural person.

Thus, S.C. MAG TRANZACT S.R.L complies with its obligations under national law and according to the Regulation undertakes the following actions:

- · Updates personal data;
- · Securely store and destroy this data;
- · Avoid collecting or storing excessive amounts of data;
- · Apply the appropriate technical measures to protect personal data;
- Protects personal data against loss, misuse, unauthorized access and disclosure.

The legal basis for the processing of your personal data

SC MAG TRANZACT S.R.L may process your personal data using one or more legal grounds presented below:

- the data subject has given his / her consent for the processing of his / her personal data for one or more specific purposes;
- Execution of a contract: the processing is necessary for the execution of a contract to which the data subject is a party or to take steps at the request of the data subject before concluding a contract;
- Compliance with legal obligations: processing is necessary to comply with the obligations of the operator arising from laws or other regulations;
- The vital interests of the data subject: processing is necessary to protect the vital interests of the data subject or of another natural person;
- Public interest or public authority: the processing is necessary for the fulfillment of a task that serves a public interest or that results from the exercise of the public authority with which the operator is invested.
- The legitimate interest of the controller: the processing is necessary for the purpose of the legitimate interests pursued by the controller or a third party, unless the interests or fundamental rights and freedoms

of the data subject prevail, which involve the protection of personal data, especially when the person concerned is a child.

Transfer of personal data to other entities

There may also be circumstances in which we need to transfer your personal data to certain providers who provide services to us. Any third parties to whom we communicate your data are obliged to keep this data safe and use it only to provide the service they have provided on our behalf. When they no longer need your data to provide this service, they will destroy it according to the procedures in force. In the situation where we have to transmit your sensitive personal data to these providers, we will do so only after obtaining your consent, in the situation where there is no legal basis for this transfer.

Duration of processing / retention of your personal data

At the same time, we inform you that we will not keep your personal data longer than is reasonably necessary, in accordance with the purpose of this processing or in accordance with the applicable legal obligations.

Your rights regarding personal data

Unless you are subject to an exemption under the Regulation, you have the following rights with respect to your personal data:

- Right of access you have the right to request a copy of the information we hold about you;
- Right to rectification you have the right to correct the data we hold about you, if they become inaccurate, incorrect or incomplete
- The right to be forgotten in certain circumstances, you may request that the data we hold be deleted from our records:
- The right to restrict the processing under certain conditions, you have the right to request the restriction of the processing of your personal data;
- The right to portability you have the right to request the transfer of the data we hold about you to another organization, if the applicable conditions regarding this data are met;
- Right to object you have the right to object to certain types of processing, such as, for example, processing for direct marketing purposes. Your right to challenge the processing of your personal data for the purpose of direct marketing communication is absolute and will not be denied under any circumstances;
- The right to oppose automatic decision-making (eg profiling) you also have the right to oppose your submission to the legal effects of automatic profiling or profiling;
- The right to file complaints if we refuse your request for access to personal data belonging to you, we will give you a reason for refusal. If you are dissatisfied with the answer, you can contact the Data Protection Officer S.C. MAG TRANZACT S.R.L and further relevant authorities (ANSPDCP).

Special circumstances

- **Data transfer abroad** If personal data will be transferred to countries or territories outside the European Union, we will provide details on how the data will be protected, along with details on how to obtain the relevant guarantees.
- Automatic decision making If we develop a process to automate decisions through the processing of your personal data, we will provide details of any such processing along with information about the logic involved and the meaning and consequences of processing.
- Further processing If we wish to use your personal data for a new purpose, which is not covered by this Data Protection Notice, we will provide you with a new notice explaining this new use before processing and setting the relevant purposes and processing conditions. When and whenever necessary, we will seek your prior consent for new processing.

Cookies Policy

The cookie is a small file (alphanumeric), which is stored on the computer, mobile device or any other equipment that the User uses to access the Internet. It does not contain software, viruses or spyware and cannot access the information stored on the User's hard drive. Cookies do not require personal information to be used.

The http://www.mag-ingenieure.de website uses both its own cookies and those of third parties, in order to facilitate a superior browsing experience and services in accordance with their specific needs. The role of cookies is to permanently improve the browsing experience within the website, through the following aspects:

- · Possibility to customize various settings;

Provisions regarding data security and confidentiality

We assume, instead, adequate measures, of a technical and organizational nature, in order to guarantee the security of the data, but we cannot ensure that the information that the User receives or uses through the Internet will be permanently safe. Going further, S.C. MAG TRANZACT

S.R.L. suggests that you check the security policies of the browser you use, as well as the terminal you use, for the existence of software against viruses of any kind or any external hacking or cracking attacks.

Cookies are not viruses, but can be used for harmful purposes in the form of spyware.
